RE: Call for Officials for the 2019 Canadian Junior Closed Championships

The 2019 Canadian Junior Closed Championships will be held April 11-14, 2019 at The Royal Glenora Club in Edmonton, Alberta. Squash Canada and Tournament Referee Curtis Gillespie are currently seeking applications from individuals who are interested in officiating at the event to compliment player referees.

Application Requirements – officials must submit by email the following information:

- Name, Email Address, Phone Number, City, Province and Shirt Size
- Current officiating level and recent officiating experience in last 6 months
- Availability during the event (please indicate full-time, part-time, specific days).
 - We will be staggering the days that referees are required, to match up with the tournament demands. Accordingly, not all referee acceptances will be for the full 4 days.
 - Consideration will be given to officials who can work full time (all 4 days)

Selection Criteria

Squash Canada will provide funding for 8 referees and expects that it can accommodate up to an additional 4 unfunded referees if sponsored by the Provincial/Territorial Association.

Funding Details:

The approved plan for 8 funded officials and 4 unfunded officials is as follows:

- 1) Meal vouchers and access to all social events while working will be provided by host venue
- 2) Tournament Package/Souvenir plus one Referee Shirt provided by host venue
- 3) Each official will receive a daily stipend as follows based on two shifts per day and that officials will generally participate in both shifts (shifts defined as Early Shift – 8am to 3pm / Late Shift – 2pm to 10pm):
 - a) National Referees – \$40 per shift
 - b) Provincial Referees - \$30 per shift
 - c) Local/Club Referees – N/A
- 4) Travel subsidy for the 8 funded officials – \$60 for those travelling at least 100 kilometres
- 5) If requested, accommodations will be provided for all 8 funded officials plus the 4 unfunded referees approved by Squash Canada. Note: Tournament Referee, Host Committee and Squash Canada will coordinate the accommodation logistics and confirm details closer to the event.

Selection Process:

1. Applicants will submit their application to officiate by the deadline Friday March 8, 2019 at 2PM EST
2. The Tournament Referee and Squash Canada will review applications and make selections.
3. All applicants will be contacted by the Tournament Referee by Friday March 15, 2019 at 2PM EST
